### With whom and for what purposes is your personal data shared?

In addition to the purposes stated in this text, we share your personal data with external service providers (website developers, database providers, etc.) in connection with the purpose of carrying out our association activities in accordance with the Personal Data Protection (KVK) legislation.



Third parties with whom we share your personal data are obliged under our contractual relationship to process and protect your personal data for the purpose of sharing, unless otherwise stipulated in the Personal Data Protection (KVK) legislation and are under the control of TCA.

- To know the third parties to whom it has been transferred at home / abroad, to request correction if it is incomplete / wrong;
- To request deletion / destruction within the framework of the conditions stipulated in Article 7 of the Personal Data Protection (KVK) Law;
- To request the deletion and destruction of your personal data within the scope of Article 7 of the Personal Data Protection (KVK) Law and the correction of incomplete / incorrectly processed personal data to be notified to the third parties to whom the personal data has been transferred;
- To object to the emergence of a result against you due to the analysis exclusively by automated systems,
- We inform you that you have the right to demand the compensation of the damage in case you suffer damage due to unlawful processing.
